# Priors Marston Parish Council Meeting Tuesday 9<sup>th</sup> November 2021 at 7.30pm Priors Hall, Shuckburgh Road.

#### **DRAFT MINUTES**

Meeting was opened at 7.35pm.

**1. Apologies:** none

2. **Declarations of Interest:** None

3. Approval of the minutes of the last meeting held on Tuesday 14<sup>th</sup> Sep 2021 Minutes were approved by all present at the meeting, as a true record. Signed by the Chair.

## 4. Comments and Questions from the public:

A member of the public spoke on item 5.2 of this agenda – Traffic calming. There is concern over speeding vehicles through the village, but especially on Southam Road. The Parish Council were asked if it acknowledged there was a speeding problem and what can be done.

Cllr Lucas explained the Parish Council had commissioned a radar survey 2 years ago, which gathered date over one week 24/7.

Data:

1300 vehicles of varying sizes were captured

8am-9am Are the busiest times and 2-3am the quietest times.

Although average speeds on the Southam Road exceeded the speed limit, overall the conclusion was that speeding in the village was not considered to be a significant problem.

Discussions took places with other members of the public present over what can be done to promote safer driving. It was acknowledged that sometimes it is inconsiderate driving rather than going over the speed limit. Where Southam Rd narrows Highways will be asked to re paint the slow signs on the road. Rumble strips cannot be within 400 meters of a house due the level of noise produced.

<u>County Cllr Chris Kettle spoke as representing the County Council who are responsible for Highways.</u>

Every parish in the last month in his area has had concerns over speeding and dangerous driving. Dangerous drivers sadly are not concerned over traffic calming measures and ignore them. It is about driver behavior rather than speeding.

The Highways budget cannot sustain the introduction of further calming measures in every parish. They are used where there is a historic track record of serious injury/deaths and no funding available for areas without this track record.

Any reports of dangerous driving should be reported to the Police on 101 who can build a picture this can be followed up by the Safer Neighbourhood Team. Although this is only really helpful if you have the number plate and it's a consistent had driver.

In conclusion it was resolved to:

- 1) Contact the Police on the speed watch in the village that the Clerk has requested.
- 2) Research starting a Community Volunteer Speeding Action Group in conjunction with the Police.
- 3) Contact Highways to see if existing signage can be improved.

Once data from the speed checks is back further advice can be sought. Action Clerk.

### 6. District Cllr Nigel Rock Update

#### Covid Rates.

Over recent week Covid infections in the District as a whole have been higher than they have ever been, but are now starting to fall back from around 500 per 100,000 a week ago, to below 400. However the Southam and Feldon areas have been almost double these rates and, for reasons not clear, our local area is something of a hotspot. This is at odds with previous experience where our rural areas tended to be lower. So considerable caution is required, although measures such as wearing masks in confined public places, such as shops, are not yet being required by the Government.

Whilst the majority of cases are still in school age children there have been increasing numbers in the over 60s which is a particularly vulnerable group. Personally I am perplexed by the Government's messaging that controls are not needed, because it seems that many people think the pandemic is more or less over .

## **Boundary Review & Merger**

Work on the potential merger between and Stratford and Warwick District Councils has been continuing and the consultation has now closed. A representative sample of residents has been contacted for their opinions, and an analysis of responses is underway. Meanwhile, there are Boundary Commission proposals for changing council ward boundaries if no merger takes place. The Commission's proposal involves a mixture of single councillor wards and wards shared between councillors, as well as some strange looking boundaries.

At a series of meetings, Stratford Council has resolved to resist the Boundary Commission proposals in a couple of key matters: 1. that the Boundary Commission have not respected the Council's wish for single member wards, and 2. that the very large two-member ward the Commission proposed from the M40 to Shuckburgh is not acceptable.

The date for responses to the Commission has been extended to 6th December.

The Council went on to unanimously agree a way that overcomes both issues. I had considerable input to that response. No one thinks the choices are entirely satisfactory being driven by numbers rather than communities. Getting the same number of electors for council wards around Southam is impossible while keeping to Southam parish boundaries, so there have had to be some compromises. The Council's response is at

### 7. County Cllr Chris Kettle Update

Highways – As discussed this evening Cllr Kettle will continue to support where he can on any traffic issues.

HS2 –The Wormleighton/Upper Boddington works on the trees are currently going ahead. Chair asked why so many hedgerows around this area are being removed.

The land required to clear the way for the bridge and re-divert the road takes a lot of land hence why there are a lot of trees and hedgerows being removed in this area.

The HS2 meeting was attended by Cllr Rock and Cllr Kettle where they discussed the diversions and road closures on the A45 and A425 clashing. HS2 acknowledged they had made a mistake and the A425 closure was delayed.

Avian Flu in Warwickshire. A bad strain is in the area and posters have been disseminated to Parishes to warn residents and explain the process if they come across a dead or injured bird. This information has been emailed to residents and put on social media.

## 8. <u>Improving Village Signage</u>

Discussion took place on potentially improving the Priors Marston signs when entering the village. Stone flower beds for example. This was seen as a positive idea and one to investigate, acknowledging there would be an on going maintenance responsibility and volunteers required.

#### 9. **The Pound**

This is an area of land owned by the Parish at the rear of Holywell House and the Churchyard. The owners of this property have approached the Council and wish to purchase this land (Currently rented to them for £250 a year)

The Council have visited the property and are open to investigating this further and get a valuation.

Cllr Dunkley will assist the Clerk in this matter and gain 3 valuations. If cant get parity we can contact the District Valuer.
