# 4. Outstanding Actions & Matters Arising

# • Housing Needs Survey

The questionnaires have been received from WRCC and will be sent to all houses with the next parish magazine deliveries.

# • Playground Maintenance

Following on from the recent installment of the new junior swings it was noted that the timber frame is in need of replacing soon. It was resolved to book another RoSPA inspection (last one was August 2022) and plan a maintenance plan accordingly once the report is back.

The moss needs to be removed from the playground flooring. It has been advised not to use anything with chemicals in it as will ruin the rubber.

#### Footpath Maintenance

# • Radar Vehicle Survey

Following on from the previous meeting it was resolved for the council to procure a radar speed survey which is provided by the Traffic Survey Team at Warwickshire County Council. This will be charged to the Parish Council at approximately £220+VAT per radar (for 2 weeks data) for which we require 5, 1 for each road. The Traffic Survey Team have asked that the Community Speed Group choose the

locations of the radars at their request. This action was sent to the group on the  $15^{\rm th}$  December and we await that work to be done prior to organizing the date of the survey. It has been reiterated the Community Speed group that the data needs to be accepted and that the data will not in any way mean that WCC or Highways will act upon it.

# 5. Precept and Budget 2024/25

The Budget for 2024/25 has been agreed and it was agreed for the precept to remain unchanged at £18,560. 00 for the 24/25 period.

# 6. District Cllr Nigel Rock Update.

#### The New Council Plan

The New Council Plan which will guide the administration for the next four years was voted for at Full Council on 11 December 2023. Detail below and at : Council Plan 2023 - 2027 | Stratford-on-Avon District Council

#### **Budget**

The administration is in the process of setting a budget for the year 2024/5. Central government advises local authorities of their settlement figures on an annual basis, and the final figure was reported to SDC on 22 December. Due to these tight timescales, Cabinet has been working on the budget for some months prior to the central government figures being announced. Following the Christmas break the preliminary figures have now been finalised to achieve a balanced budget. We are pleased to announce that no cuts to services are anticipated. The budget will be out for public consultation, which is expected to commence on 19 January, upon which we welcome comments.

# **Cost of Living Support**

We should like to remind residents that there is wide-ranging help and support available from the District Council if they are worried about the cost of living, which affects health and wellbeing. ## **Community Safety**

There have been a series of reports of break-ins, key and car thefts villages recently. This has affected Southam (including the fire station), Bishops and Long Itchington, and Fenny Compton. We also attach advice from Southam SNT at the end of our report.

Currently, the future operations of WCC Fire and Rescue service is being debated. The matter was raised at the last Council meeting. The District Council is concerned that cover is not depleted, noting the difficulty locally in maintaining Southam and Fenny Compton stations, but we want to ensure that full facts are considered and to that end we have asked for a full presentation to District Councillors.

## 6. County Cllr Christopher Kettle Update

Warwickshire Fire and Rescue Service with particular reference to Fenny Compton Fire Station.

In summary the WFRS volunteer call out service, which was historically available for 90% of the time pre pandemic has fallen across the County to 35% and the 12 fire appliances which are crewed by on-call firefighters are, on average, only available one-third of the time. This is unsustainable. In particular Fenny Compton, since May 23 has dropped to an average availability over six months of 9.4%. In the absence of a rapid improvement in call-out personnel availability, changes to how the service is delivered must be considered.

# **Harbury Crossroads**

Work is now continuing on the crossroads with a targeted completion date of the spring. There is a clear programme and timetable for this work and I would hope that we are now entering the final stages of the significant road safety improvement project.

#### **Highway road improvements**

Councillors should be aware that WCC, after consideration by a Council appointed working party, made the decision some months ago not to introduce mandatory 20mph speed restrictions in village communities. Recently Oxfordshire CC have decided to so which is clearly of concern to those residents living near the Oxfordshire border. Residents may also be aware that Fenny Compton has a legacy 20mph limit in the centre of the village and Southam has just announced that HS2 are funding a 20mph limit from their community support budget in the centre of the town.

Councillors should be aware of the two HS2 funding schemes set up to mitigate for the impact of HS2 on the community being the Business and Local Economy Fund (BLEF) and the Community and Environment Fund (CEF).

Clearly each application must demonstrate a need and justification for the funding

Recently a total of 25 differing and widely ranged schemes have been put forward to be funded by HS2.

These 25 schemes have been investigated by the County Councils own Traffic & Road Safety Team and have put each scheme forward to the HS2 Board. The scheme through Southam, is to apply a 20mph speed limit along the main shopping route through the town of Southam. The move received support from Southam Town Council.

Any community can apply for funding from HS2 for the two grants to mitigate for the impact of HS2. Examples of CEF funds are as follows:

- Improved pedestrian, equestrian, or cycle access not provided under statutory services;
- Landscape and nature conservation enhancement projects which increase biodiversity (including pop up interventions such as skip gardens);
- Enhancement or replacement of sports and recreational facilities;
- Improved access and enhancements to public open space;
- Provision of enhanced or new community facilities; and
- Refurbishment/re-use of historic buildings and monuments.

#### HS<sub>2</sub>

I have had no further response from BBV about complaints about the attempted eradication of noxious weeds on the land acquired by HS2.

I, as have WCC officers, have written back to make it clear that work practices that do not comply with DEFRA published guidelines are not really an acceptable response..
