### 3. Approval of the minutes of the last meeting 9th September

Minutes approved by all present at the meeting as a true record and signed by Cllr May in Chairs absence.

# 4. Outstanding Actions Matters Arising/Correspondence/Questions

HT raised ongoing concerns about the blocked drain on Keys Lane, which remains unresolved despite gully cleaning in 2024. Water continues to flow down the lane, posing a risk in icy weather. Cllr Kettle reported that there are 63 gulleys in the area—11 cleaned every 6 months and the remainder on a 2-year cycle, all last cleaned in 2024. The blocked drain on Keys Lane has been assessed as low priority by Highways as it is not considered to have a severe impact on people or property. HT disputed this, citing a parishioner who has experienced property impact and safety issues due to ice. Cllr Kettle asked that the parishioner contact him directly with details so he can investigate further. **Action:** HT to ask the parishioner to email Chris K with relevant information.

#### War Memorial

The restoration work has been completed by M. Powers & Sons Stonemasons. The Parish Council agreed that the quality of the workmanship was excellent, and feedback from parishioners has been very positive. The Remembrance Service held on 11th November was well attended and respectfully observed

# • Streetlight (Hellidon Road)

The costs have still not been received from WCC *Decision:* Item deferred pending further information.

#### Defibrillator

There has been a good response for volunteers to become Defibrillator Guardians and register on *The Circuit*. Five Guardians will be registered, including the Clerk. Parishioner Jan Southam, a qualified first responder and registered Guardian, has kindly offered to provide defibrillator and basic first aid training for the village free of charge, with voluntary donations on the day in support of the Air Ambulance. The training session will be organised in the new year. Action: Clerk

## 5. Playground project update

Clerk updated the PC:

First Working Group meeting was held on 19<sup>th</sup> September. The working group consists of local parents and Cllr Mills and the Clerk. Anyone else interested in being involved in any way is welcome to contact the Clerk for more information.

The Actions from the Group were as follows:

- Arrange a workshop for the Priors School children organized by the PTA. To include activity sheets and opportunities for the children to express their ideas.
- Community Grant application Cllr Mills to apply.
- To arrange community consultation possibly with potential suppliers in the new year.

PET have asked the PC to consider a concrete table tennis table to be included in the design to appeal to older children. This would be kindly funded by PET. It will be discussed at the next working group meeting however ultimately it will be down to the design and space for it without neglecting any other equipment. *Resolution:* The Council noted the update and agreed the next steps as outlined.

### 6. Update County Cllr. Chris Kettle

## **Summary of the Report:**

## Council Extraordinary Meeting - 14 October

The Council met to discuss its response to the Government's consultation on unitary authorities. Three motions were approved:

- 1. Support for the retention and creation of parish and town councils.
- 2. Agreement that full constituent membership of the West Midlands Combined Authority is the best devolution arrangement for Warwickshire.
- 3. Support for a single unitary council for Warwickshire as the most effective model of local governance.

#### **Financial Case:**

- A single unitary authority is significantly more cost-effective than two.
- Over 5 years:
  - o Single unitary: £57.1m net benefit.
  - o Two unitaries: £11m additional cost.
  - Difference: £68.1m.
- Transition costs: £22.3m for a single unitary (30% lower).
- Disaggregation costs: £0 for single unitary vs £8.6m per year for two.

#### HS<sub>2</sub>

- The B4451 will close from 11–14 November (daytime only) to enable a new water supply connection near Southam Rugby Club.
- Some vegetation will be removed, but the original hedgerow will remain intact.

# **Highways**

- Keys Lane drainage gulleys were jetted and repaired last winter; most gulleys are on a 2+ year cleaning cycle.
- Some highway patching took place recently.
- Concerns raised about the extended diversion during works on The Holloway

   considered unnecessarily long.
- New chevrons installed on the B4451 (funded from the councillor's delegated budget); further pavement improvements due in spring.
- Officers exploring funding for a third gateway sign on Ufton Hill.

#### **Severn Trent**

- Concerns raised over diversion routes and full road closures during works on the B4451.
- Severn Trent admitted one diversion was unsuitable and removed signage but offered no alternative.
- A written explanation has been requested for why a full closure was necessary when past bursts were managed with traffic lights.

### Hambridge

- Repairs completed, but the bridge was damaged again after an HGV ignored closure signs.
- The bridge is closed again pending more substantial repairs; "Road Narrows" and reduced weight limit signs will be installed before reopening.

## **Budget 2026/27**

- Budget planning for 2026/27 will begin soon.
- 2025/26 forecast: minor overall overspend, though social care and education costs are significantly over budget.
- The SEND deficit remains a major issue expected to reach £150 million by year-end.
- The Government's "statutory override" temporarily offsets this but future SEND funding decisions are awaited.
- Council tax cannot be used for education, which is funded through the central DSG grant.

## **Flooding**

- WCC continues to support flood alleviation in **Long Itchington**, despite it being beyond statutory duties.
- Drainage improvements completed on **Station Road, Fenny Compton**.

# **Summary of Report:**

# **Planning and Housing**

 Five-Year Housing Land Supply: Stratford District Council lost its five-year housing land supply following an appeal judgement, triggering the need for a strategic response to increase housing permissions.

- An action plan (in Cabinet papers, 6 Oct 2025) sets out steps to restore supply.
- A new advisory group of councillors will help identify the "least worst" sites for development.

### GreenBelt&GreyBelt

Much of northern Stratford is Green Belt. The government's proposed "grey belt" policy (to free up some Green Belt land) is seen as confusing and unhelpful.

## Staffing

Like many councils, Stratford faces recruitment pressures due to national shortages of planning professionals.

### **Community Grant Scheme 2025**

- Stratford-on-Avon District Council has launched a £350,000 Community Grant Fund to mark the 80th anniversaries of VE and VJ Days.
- The fund supports capital projects to improve or create community facilities
   e.g. halls, parks, play areas, or memorial spaces.
- Two funding levels:
  - o Small Grants: £5,000-£20,000
  - Large Grants: £20,001-£100,000
- Information sessions: 12–14 November.
- Application deadlines:
  - o 31 January 2025 (Small Grants)
  - 27 February 2025 (Large Grants)

# District Statistics (2014–2025 Overview) Population

- Increased by 19.74% (2014–2024) 8th highest growth in England & Wales (national average 7.74%).
- Over 65s: 25% of population (UK average 19%).

## **Housing**

- Housing stock: more detached homes, fewer flats than Warwickshire or national averages.
- Bungalows only 10%, despite an ageing population.
- House prices:
  - Median down £25,000 from Sept 2023.
  - o Still 19% above Warwickshire and 21% above England medians.
  - o Price-to-earnings ratio: 9.07 (now slightly below Wychavon).
- Private rents: average £1,069/month, third highest in the West Midlands.
- Vacant dwellings: approx. 2,287 (Oct 2024).
- New homes: 1,011 added in 2023/24 138% of target, ranking 15th of 164 districts nationally, though the Council still failed the 5-year supply test.

#### Crime

- Total recorded crimes (to July 2025): 10,108 up 2,204 from the previous year.
  - o Increase partly due to data reporting changes.
  - o Crime rate: 69 per 1,000 people (Warwickshire: 56).
- Most common offences:
  - Violent/sexual offences: 22.6 per 1,000 (below national and county averages).
  - Vehicle crime: 5.43 per 1,000 (slightly above Warwickshire and England averages).
  - Highest vehicle crime area: Harbury, possibly linked to JLR site boundary.

# **Employment and Fuel Poverty**

- Employment: 15% of residents aged 16–64 classed as economically inactive; 1,685 unemployment benefit claimants (July 2025).
- Fuel Poverty: 14.9% of households (West Midlands: 17%; England: 11.4%).
  - Highest rates (25%) in Ladbroke & Priors Ward, due to lack of mains gas and lower rural incomes.
