# 2. Questions from Residents

Presentation from Malcolm & Rosemary asking for support in the awareness of the church as a community building. The church tower is in need of restoration which will cost £199, 000, this is an important building for the village. Priors Marston Parish Council acknowledges the community role of the church and record the intension to make affirmation in the current village plan and future plans.

**4. Approval of the minutes of the last meeting, held on 6<sup>th</sup> November 2014** Approved. Proposed VN, Seconded EJ

#### 5. Parish Clerk

Helen Keeves has formally been appointed as the Parish Clerk after successfully completing a 6-month probation period, further more a pay increase effective from 1<sup>st</sup> Jan was agreed inline with WALC's banding recommendations. There is a pension scheme available through WCC, which the councilors have agreed she should investigate.

# 6. Matters arising from previous meeting

a. Highway Issues

#### **Holloway Flooding**

Logged our concerns at the Warwickshire Flood Workshop and will wait further advice. In the meantime we have an emergency kit which will be allocated in the telephone box once the defibrillator is installed.

# **School Road Kerbing**

WCC suggested the best solution would be concrete kerbing that can be driven over, and repairs where required to the road, agreed to go ahead, this is with Highways and

awaiting a timescale. Cllr Appleton asked if granite could be used? HK will investigate.

## Signs/SLOW

In hand with Richard Elbourne from WCC Traffic, no update, pushing for timescales.

#### Bus Shelter Fruit Trees

Overgrown trees have been examined by WCC Highways and advised they do not belong to WCC therefore the responsibility of the parish council, will contact tree surgeon for advice on pruning and preservation.

#### Horse Chestnut Tree School Lane

Have asked WCC highways Forestry to check this tree and advise on its health

#### The Orchard

Further to a meeting with a WCC solicitor it was confirmed that land adjacent to The Orchard unusually has duel ownership as village green and dedicated highway. The issue of the stone obstructions are being considered.

#### b. Defibrillator

The 90 day telephone box consultation with BT & Stratford District Council has come to an end and Priors Marston Parish Council have purchased the telephone box in the village and are awaiting BT to decommission the telephone so a defibrillator can be installed.

# c. Playground repairs, annual inspection

Repairs and annual inspection completed. The Parish Council will conduct regular checks to ensure well maintained.

Councilors agreed a sign should be erected in the playground advising equipment designed for use by children only.

#### d. Village Greens

Project launched to ensure all village greens within Priors Marston are registered to Priors Marston Parish Council.

Cllr Stevens advised of contact details for footpath maintenance

#### 7. **Precept**

The precept for 2014/2015 was £16,500. It has been proposed and agreed by all councilors that for 2015/2016 the precept is increased to £17,500 allowing £1000 to assist with election costs for this financial year.

New Transparency Code of Practice

Any Parish Council with expenditure less than 25K will be required to adhere to a new code of practice as of Spring 2015. The reason for its introduction is that the financial year 2016-17 will be the last that councils of this size will be subject to external audit. After that they will be exempt from external audit, however they will be expected to publish more information. The Code therefore will allow council tax payers to have access to relevant information about the councils' accounts and governance and this will subsequently become law.
