3. **Questions from Residents**

- a. Street Lighting
 - Street Light not working outside playground/church reported to WCC
 - Street light on Keys Lane is leaning over, looks like it has been hit by a vehicle – WCC to investigate

b. Fly Tipping

Reported fly tipping on Keys Lane – a large piece of wood, possibly a wardrobe half way up the hill – This has been collected and disposed of.

c. Roads

State of road on Keys Lane – grass verges have been driven over and wooden markers have been knocked over – WCC to investigate

6. Matters arising from previous meeting

a. Highway Issues

School Road Kerbing

This has been completed and will be monitored by the PC

Signs/SLOW

Awaiting one SLOW sign (on the road) to be re-instated on the Southam Road

Footpaths

Simon Brown has volunteered to review the footpaths within the village, identify their condition and report back to the Parish Council in the January meeting.

Village Green

WCC has written a letter to the homeowners of The Orchard asking that the stones be removed, which are obstructing the village green. WCC has asked for them to be removed within 14 days.

b. Defibrillator

Telephone box has been re-painted, new signage is ready to install as soon as defibrillator is fitted, and this is booked in for the second week in November.

Maintenance

It was agreed by all that a revision of all village benches and signage needs to take place, Cllr Franklin agreed to review with the Parish Clerk.

7. Housing Needs Survey

This has been completed and the Parish Council are happy with the report and are willing to adopt this if the following amendments are made:

- a. We believe aspirations have been addressed but not necessarily affordability
- b. It was suggested that additional housing for the village should sited on one location, the Parish Council have a preference for split locations.
- c. Keep any additional housing within the conservation area.

Agreed the Parish Clerk will prepare an overview of the findings for the Parish Newsletter.

Next Action is to update the Parish Plan so this is in place for when Stratford District Councils Core Strategy is adopted.

8. District and County Councilors - update

Cllr Chris Williams - District Councillor

Budget

The District Council is currently considering its budget proposals for 2016-17. The indication from the Treasury is that there will be significant reductions in settlement allowances but the District Council, unlike the County Council, does have to fund large public services such as Health and Education. I am expecting that for the fifth year running, Stratford District Council will be able to freeze Council Tax. I will keep the Parish Council updated.

West Midlands Combined Authority – Since my last report of 14th September 2015, the District Council have voted to change their status of being a Shadow Member of the West Midlands Combined Authority. They have been advised that such a position could only be taken up if WCC had elected to be a member of the Combined Authority. As Warwickshire County Council is not a member of the West Midlands

Combined Authority, SDC took a vote and confirmed that they were no longer applying to be a member.

Stratford has joined Warwick District Council, Rugby Borough Council, North Warwickshire Borough Council, as well as Warwickshire County Council in not being a member of the West Midlands Combined Authority. WCC is currently negotiating with other Shire counties to establish a more appropriate allegiance.
